The Nifty futures open interest has decreased substantially by 4.76%. The INDIA VIX increased from 19.98 to 20.47. The Nifty June future closed with a discount of 7 points against a discount of 18 points in the last trading session. The June series closed at a premium of 6 points.

<u>View</u>

Indian bourses witnessed a negative move in today's session as Nifty closed below 16600 amidst selling in last hour. Buying is seen in Nifty Auto, Nifty FMCG, Nifty Metal, Nifty Realty, Nifty PSE and Nifty Media whereas selling is seen in Nifty PSU Bank, Nifty IT, Nifty Finserv, Nifty Pharma, Nifty Bank and Nifty Commodities. Highest buying is seen in Nifty Metal and Nifty PSE and highest selling is seen in Nifty Bank.

FIIs were net sellers today, they sold to the tune of Rs. 1003 Cr whereas DIIs bought net 1845 Cr worth of Indian shares. With the fall in open interest and fall in Nifty, there are indications of long unwinding.


As per the F&O data, short buildup has substantially increased in, in the money calls, whereas long unwinding is seen in, out of the money puts which indicates a negative market. 16700 and 16600 have high short built-up whereas 16600 and 16500 has high long built-up. Max pain of nifty is at 16500. Nifty pcr is at 1.10 whereas bank nifty pcr is at 0.75.

Top Short build up: Aartiind, Metropolis, Glenmark, Godgrejprop, Sunpharma.






