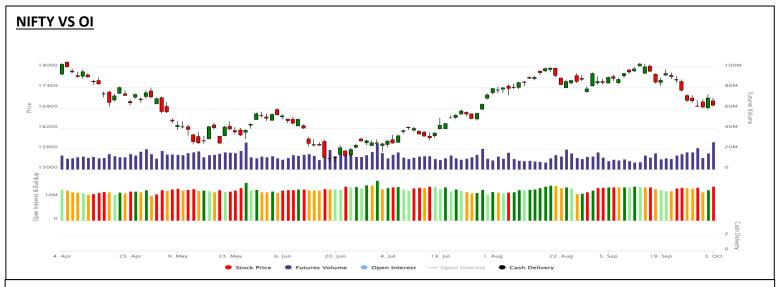

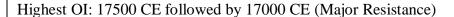
The Nifty futures open interest has increased substantially by 11.61%. The INDIA VIX increased from 19.96 to 21.36. The Nifty October future closed with a premium of 8 points against a premium of 9 points in the last trading session. The November series closed at a premium of 51 points.

View

Indian bourses witnessed a negative move in today's session as Nifty closed below 16900 amidst increased volatility. Selling is seen across all indices today except Nifty Pharma, Nifty PSE and Nifty CPSE. Highest selling was seen in Nifty Metal whereas highest buying was seen in Nifty Pharma.

FIIs were net buyers today, they bought to the tune of Rs. 590.58 Cr whereas DIIs sold net Rs. 423.16 Cr worth of Indian shares. With the rise in open interest and fall in Nifty, there are indications of short buildup.

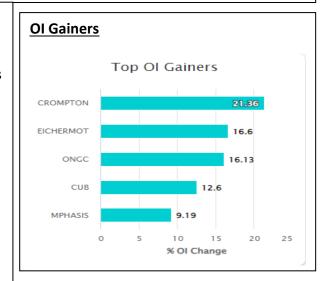
As per the F&O data, short buildup has substantially increased in, in the money calls, whereas long unwinding is seen in, out of the money puts which indicates a negative market. 17500 and 17000 have high short built-up whereas 16800 and 16500 has high long built-up. Max pain of nifty is at 17000. Nifty pcr is at 0.94 whereas bank nifty pcr is at 0.76.

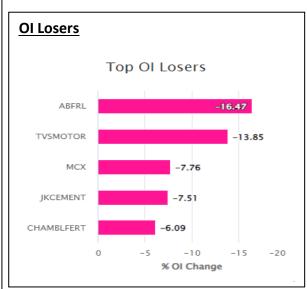


Highest OI: 16800 PE followed by 16500 PE (Major Support)
