The Nifty futures open interest has increased substantially by 6.59%. The INDIA VIX increased from 21.25 to 22.03. The Nifty May future closed with a discount of 3 points against a premium of 8 points in the last trading session. The June series closed at a premium of 4 points.

<u>View</u>

Indian bourses witnessed a negative move in today's session as Nifty closed at around 16300 amidst massive gapdown opening. Selling is seen across indices as all indices closed in red. Highest selling was seen in Nifty Energy, Nifty PSU Banks, and Nifty Metal.

FIIs were net sellers today, they sold to the tune of Rs. 3361.80 crores whereas DIIs bought net 3077.24 crores worth of Indian shares. With the increase in open interest and fall in Nifty, there are indications of short buildup.


As per the F&O data, short buildup has substantially increased in, inthe-money calls, whereas long unwinding is seen in, out of the money puts which indicates a negative to sideways market as downisde is open and upside is limited. 16500 and 16400 have high short built-up whereas 16200 and 16000 has high long built-up. Max pain of nifty is at 16400. Nifty pcr is at 0.79 whereas bank nifty pcr is at 0.64.




