
The Nifty futures open interest has increased substantially by 1.44%. The INDIA VIX increased from 22.30 to 22.80. The Nifty May future closed with a premium of 10 points against a premium of 7 points in the last trading session. The June series closed at a premium of 47 points.

View

Indian bourses witnessed a negative move in today's session as Nifty closed below 16200 amidst global sentiment. Buying is seen in Nifty Bank, Nifty Finserv, Nifty Commodities and Nifty Realty whereas Selling is seen in Nifty FMCG, Nifty Auto, Nifty Pharma, Nifty Energy and Nifty PSU Banks. Highest selling is seen in Nifty Auto and highest buying is seen in Nifty Realty.

FIIs were net sellers today, they sold to the tune of Rs. 3909.35 whereas DIIs bought net 4181.2 crores worth of Indian shares. With the increase in open interest and fall in Nifty, there are indications of short buildup.


As per the F&O data, short buildup has substantially increased in, inthe-money calls, whereas long unwinding is seen in, out of the money puts which indicates a negative to sideways market as downisde is open and upside is limited. 16300 and 16200 have high short built-up whereas 16200 and 16000 has high long built-up. Max pain of nifty is at 16300. Nifty pcr is at 0.69 whereas bank nifty pcr is at 0.85.


