

#### **Comments**

The Nifty futures open interest has increased by 3.63%. The INDIA VIX increased from 18.25 to 18.41. The Nifty October future closed with a discount of 11 points against a premium of 10 points in the last trading session. The November series closed at a premium of 28 points.

#### <u>View</u>

Indian bourses witnessed a positive move in today's session as Nifty closed above 17300 amidst directional buying. Buying is seen in all indices today except Nifty Metal, Nifty Realty and Nifty Media. Highest buying was seen in Nifty PSU Bank whereas highest selling was seen in Nifty Metal.

FIIs were net sellers today, they sold to the tune of Rs. 372.03 Cr whereas DIIs bought net Rs. 1582.24 Cr worth of Indian shares. With the rise in open interest and rise in Nifty, there are indications of long buildup.


As per the F&O data, short covering has substantially increased in, out of the money calls, whereas long buildup is seen in, in the money puts which indicates a positive market. 17500 and 17300 have high short built-up whereas 17300 and 17100 has high long built-up. Max pain of nifty is at 17300. Nifty pcr is at 1.11 whereas bank nifty pcr is at 1.39.

Highest OI: 18000 CE followed by 17300 CE (Major Resistance)

Highest OI: 17300 PE followed by 17000 PE (Major Support)

Top Long Build up: Canbk, Bankbaroda, CUB, Pidilitind and Tatacomm.

Top Short build up: Oberoirlty, Navinflour, Vedl, Syngene and Hindalco.


