The Nifty futures open interest has decreased substantially by 2.24 %. The INDIA VIX decreased from 22.74 to 22.29. The Nifty May future closed with a discount of 14 points against a discount of 5 points in the last trading session. The June series closed at a premium of 5 points.

<u>View</u>

Indian bourses witnessed a sideways move in today's session as Nifty closed below 16250 amidst uncertainty. Buying is seen in Nifty Pharma and Nifty FMCG today and selling is seen across other indices. Highest buying is seen in Nifty FMCG whereas highest selling is seen in Nifty Realty.

FIIs were net sellers today, they sold to the tune of Rs. 1254 Cr whereas DIIs bought net 375 Cr worth of Indian shares. With the slight decrease in open interest and fall in Nifty, there are indications of long unwinding.


As per the F&O data, short unwinding has substantially increased in out of the money calls, whereas long unwinding is seen in, in the money puts which indicates a sideways market. 16400 and 16300 have high short built-up whereas 16300 and 16200 has high long built-up. Max pain of nifty is at 16200. Nifty pcr is at 0.87 whereas bank nifty pcr is at 0.83.


Highest OI : 16500 CE followed by 16600 CE (Major Resistance)


