The Nifty futures open interest hasdecreased substantially by 3.96%. The INDIA VIX decreased from 19.77to 18.60. The Nifty April future closed with a premium of 26 points against a premium of 11 points in the last trading session. The May series closed at a premium of 79 points.

<u>View</u>

Indian bourses witnessed a positive move in today's session as Nifty closed above 17100 amidst weekly expiry getting closer.Buying is seen in all sectoral indices except nifty bank, nifty finserv and nifty metal which closed slightly negative.Highest buying was seen in nifty auto.

FIIs were net sellers today, they soldto the tune of Rs. 3009.26 crores whereas DIIs bought net 2645.82 crores worth of Indian shares. Continuous FII selling is extremely worrying for the markets health. With the decrease in open interest and rise in Nifty, there are indications of short covering; adding to it, an inside candle is formed in Nifty.

As per the F&O data, short covering has substantially increased in, out of the moneycallsand deep in-the-money calls whereas long unwinding is seen in,out of the money puts which indicates a rangebound market as upside is limited.17500 and 17200 have the highest short built-up whereas 16500 and 17000 has the highest long built-up. Max pain of nifty is at 17150.Nifty pcr is at 0.82whereas bank nifty pcr is at 0.63.



Top Short build up: LTI, Persistent, GAIL, IGL






