

Technical Outlook: Nifty



Nifty opened with a big gapdown and closed flat in red amidst global sentiment and sideways market. On the daily chart, Nifty has made a bullish candle closing below yesterday's closing price at 17624 on spot. On the hourly timeframe, the important support zone for Nifty is at around 17450 whereas the resistance zone is at around 17800 and directional move is expected only if either support or resistance zones are broken with strength; until then, Nifty will remain sideways.

The momentum oscillator RSI (14) on the daily chart is at around 58; whereas the MACD is moving towards the center point from higher levels. India VIX has decreased from 19.52 to 19.36 levels below its 200 EMA. Max pain of nifty is at 17600. Nifty pcr is at 0.89 whereas bank nifty per is at 0.74.

Important support levels for Nifty are at around 17500, 17350 and 17200 whereas the resistance levels are at 17700, 17800 and 18000. As per the F&O data, short buildup has substantially increased in, out of the money calls, whereas long unwinding is seen in, out of the money puts which indicates a sideways to bearish market. 18000 and 17900 have high short built-up whereas 17500 and 17000 has high long built-up.
