### Bullion Index



The Benchmark index witnessed a Flat Opening on 22/2/23 and remain on range bound to lower side till evening session. However, a sharp rally seen in evening session after weakness

in dollar index but fail to break resistance at higher level makes selloff in index and resulted in price close near days low and well below previous day close.

Now, Index has Resistance at 15450-550, as long hold, more downside expected towards 15000-14800-14600 upto 14450 in short term. Other side only Sustain above 15550-15700-16000-16250 seen again 16400-16500 in days to come.

Price is trading below short term 13-days SMA and RSI at 39-mark with Downward slop indicates more room for downside in the counter. Other side below zero line MACD likely to pressure prices at every rally.

## Metals Index



The Benchmark index seen a Gap down opening on 22/2/23 and remain on lower side through out the day as recession fear and weak China demand added by fall in equity makes sell off in base metals also and resulted in price close well below previous day closing.

Now index has a Resistance at 18400-500-18800, as long hold, more Downside expected towards 17850-650-17300 in medium term. While on higher side only sustain above 18800 seen in 19300-19450 in days to come.
