

KEY HEADLINES:

The Indian rupee traded in a narrow band and closed little-changed on Thursday as likely intervention from the Reserve Bank of India limited losses in the currency.

The rupee at NSE Future 28 Nov ended weak by 1 paise at 83.30 against previous close of 83.29 and after make low of 83.07 and high of 83.31. It remained in a tight range between 83.26 and 83.29 during the day's session. Asian currencies weakened slightly.

The rupee has been range-bound between 83 and 83.2950 since the last week of September.

The dollar hit a one-week high against the Japanese yen on Thursday after Federal Reserve Chair Jerome Powell said that Fed policymakers are "are not confident" that interest rates are yet high enough to finish the battle with inflation.

The dollar index was last up 0.28% on the day at 105.80. The euro fell 0.30% to \$1.0678. The dollar gained 0.23% to 151.27 Japanese yen , the highest since Nov. 1.

Futures point to a roughly 17% chance of another hike by January, but are pricing in a 20% chance that rate cuts could come as early as March, according to the CME FedWatch tool.
