

KEY HEADLINES:

The **Indian rupee** declined versus the dollar on Wednesday after an unexpected increase in U.S. inflation spurred bets of super-sized rate hikes in coming months.

The rupee closed at 79.44 per U.S. dollar, down from 79.1475 in the previous session. The local unit had opened at 79.60, but managed to claw back from its fall, helped by Indian shares recouping a large part of their losses.

Meanwhile, rupee forward premiums tumbled to more than 10-year low, tracking the overnight jump in near-maturity U.S. Treasury yields. The 1-year USD/INR implied yield dropped to near 2.80%.

Meanwhile, foreign investors, after buying about \$6.5 billion of Indian equities last month, have purchased around \$1 billion so far in September. Overseas investment in debt since the beginning of August has been more modest at around \$500 million.

The dollar index and Treasury yields soared overnight and U.S. equities posted their biggest decline in over two years. Shares in Japan, Australia and South Korea were down up to 2.8%.

Futures are now pricing in a 1-in-3 chance that the Fed will raise rates by 100 bps next week. Prior to the inflation data, the debate among market participants was whether the Fed will deliver a 50 bps or 75 bps hike.
