- The rupee weakened sharply against the US dollar as a surge in global crude oil prices exacerbated concerns about a wider domestic trade deficit and higher inflation, given that India is a massive importer of the commodity
- The partially convertible rupee opened at 75.5430/\$1 as against 75.3800/\$1 at previous close. So far in the day, the Indian currency moved in a band of 75.5680-75.5920/\$1.
- The U.S. dollar index reached a two-week high on Monday on growing worries about Russia-Ukraine tensions and as St. Louis Federal Reserve President James Bullard reiterated calls for faster U.S. Federal Reserve interest rate hikes.
- The dollar index was last up 0.4% at 96.3090 after reaching 96.4410, its highest since Feb. 1..
