

### **KEY HEADLINES:**

- The rupee appreciated by 25 paise to 74.59 against the US dollar on Wednesday due to a pullback in the greenback and crude oil prices after Western countries imposed several sanctions on Russia for sending troops into separatist-held regions in Ukraine. At the interbank forex market, the local unit opened at 74.64 against the greenback and witnessed an intra-day high of 74.54 and a low of 74.73.
- While The rupee was quoted at 74.59 at 1530 hrs, registering a gain of 25 paise over its previous close. On Tuesday, the rupee depreciated by 29 paise to close at 74.84 against the US currency
- Meanwhile, the dollar index, which measures the greenback's strength against a basket of six currencies, declined 0.17 per cent to 95.86
- > In retaliation, the US, the EU and Japan announced a host of sanctions on Russia.
