

# **KEY HEADLINES:**

The Indian rupee recovered from mild losses to close flat on Wednesday as exporters likely sold dollars, in a low-volume session, while forward premiums fell for a third straight day. There were some monthly futures expiry-related outflows, but it was largely quiet in thin volume trade.

The rupee ended largely unchanged at 82.8575 per dollar. It fell up to 82.9225 during the session, though moved in a narrow 10-paisa range. The 82.80-82.90 has acted as a strong support zone for the currency over the past two weeks. Most Asian currencies declined as investors were divided over China's policy shift.

The dollar touched a one-week high against the yen on Wednesday, boosted by a jump in Treasury yields and investor expectations for a rebound in Chinese growth as COVID-19 curbs loosen. The dollar index , which measures the U.S. currency against six major rivals, rose 0.202% to 104.420. It hit a six-month low of 103.44 two weeks ago, when the Federal Reserve slowed the pace of its interest rate increases.

China will stop requiring arriving travellers to go into quarantine starting Jan. 8, the National Health Commission said on Monday, even as COVID cases spike. At the same time, Beijing downgraded regulations for managing COVID cases to the lighter Category B from the top-level Category A.

The key for the rupee and other emerging market currencies next year will be contingent on how the U.S. inflation and growth data shape up and how they affect the U.S. Federal Reserve rate expectations.
