

KEY HEADLINES:

The Indian rupee ended weak by 7 paise against greenback after dollar index climb to fresh 20-year high and despite positive domestic equity market foreign inflows remain mute resulted in sell off seen in Ruppe.

Overall, local equities have seen foreign investor inflows of about \$6 billion in August, the highest since December 2020. August also marked the first month this year when overseas investors turned net buyers of India's government debt.

At NSE Future exchange, Indian rupee open at 80.09 and made low of 79.95 & high of 80.12 to finally close at 79.99, a 7 paise weak over previous close.

The euro sank below \$0.99 to a new 20-year low on Monday after Russia's halt to gas supplies down its main pipeline to Europe heightened fears about a deepening energy crisis across the region.

investors are also preparing for Thursday's European Central Bank (ECB) meeting and markets have priced a near 80% chance of a supersized 75 basis point (bp) interest rate hike.
