

KEY HEADLINES:

The Indian rupee plunged against the dollar on Monday by almost 1%, marking its biggest daily decline in over 4-months, as an upbeat U.S. jobs report fanned fears of more rate hikes by the Federal Reserve, prompting analysts to reassess the prospect of more rate cuts this year.

The rupee at NSE Future fall by almost 82 paise to end at 82.83 against previous close of 82.01 and after make low of 82.26 and high of 82.86 during the day. The rupee forward premiums tumbled, tracking the jump in Treasury yields with the 1-year yield falling about 12 basis points.

The rupee and other Asian currencies found few buyers after the U.S. economy added over half a million jobs last month, blowing past expectations and boosting bets that the Fed would maintain a hawkish stance. The focus now shifts to how Fed officials respond. Chair Jerome Powell is scheduled to speak at the Economic Club of Washington, D.C. on Tuesday.

India's central bank is widely expected to raise its policy interest rate by a quarter percentage point to mark its final increase in the current tightening cycle on Wednesday before pausing to assess the impact of its hikes, according to economists estimates.

Foreign portfolio investors (FPIs) offloaded Indian equities worth 288.52 billion rupees (\$3.51 billion) in January, the most since June, data from National Securities Depository Ltd. showed.

The dollar rose to a three-week high against the euro on Monday, as Friday's blockbuster U.S. jobs report raised the likelihood of the U.S. Federal Reserve keeping on with its inflation-fighting interest rate hikes for longer.

The key for the rupee and other emerging market currencies this year will be contingent on how the U.S. inflation and growth data shape up and how they affect the U.S. Federal Reserve rate expectations.
