

KEY HEADLINES:

The Indian rupee trimmed early gains against the U.S. currency on Thursday, weighed down by dollar demand from importers and oil companies. Brent crude futures tumbled over 5% on Wednesday to their lowest in more than seven months. Hurt by concerns over the global economic outlook, Brent has fallen below \$90 a barrel from \$110 at the end of July.

The rupee was close at 79.81 per U.S. dollar, compared with 79.90 in the previous session. The local currency had opened stronger at 79.68, supported by a fall in oil prices and a recovery in most Asian currencies.

Asian currencies recovered, helped by a pullback in the dollar index . The dollar gauge dropped to 109.75, weighed down by a fall in Treasury yields and improved risk appetite. It had reached a multi-year high of 110.57 in intraday trade on Wednesday.
