## Rationale:

- > On the Daily chart, EURINR SPOT has completed 'Bullish Anti Butterfly Harmonic pattern'; the coordinates of which are:
  - XA leg is from 76.84 to 79.31
  - AB from 79.31 to 78.23 (which is 38.2% retracement of XA leg),
  - BC leg is from 78.23 to 80.58 (which is 200% retracement of the AB leg) and
  - CD leg is 80.58 to 77.40 (which is 127.20% projection of BC leg & 78.60% retracement of XA leg)
- Momentum Oscillator RSI (14) is currently reading near 30 level which is its oversold zone and probability of bounce back from said level appears high.
- > Based on the above Technical studies we can come out with a view that the EURINR may appreciate over the short period.
