## Rationale:

- On a Daily chart, BHARTIAIRTLE has been trading in a Triangle pattern for the last couple of days. Although, the price may take immediate support from the prior demand zone & lower band of pattern which indicates a bullish reversal in the counter for the near future.
- In addition, the stock has successfully given a breakout of "Consolidation Pattern" and close above the upper band of pattern, Indicating bullish strength.
- > Stock is trading above its 21, 50 & 100- day exponential moving averages on weekly & daily time frames, which is positive for the prices in the mid to long term.
- ➤ The Technical indicator Ichimoku cloud suggests that the price is trading above the cloud, which points out positive strength.
- At the same time, an oscillator Stochastic is also suggested a positive crossover which confirms the continued bullish trend.
- ➤ Based on the above Technical studies we can come out with a view that the price may move towards higher levels over the short period.
