- January future on Friday close at 23500.65 on a negative note with 2.24% increase in OI and with a price decrease by -0.62% (-147.45) indicating Short Buildup. (SB)

- Annualized volatility index VIX has decreased from 15.65% to 14.915% down by 4.70%.


Bank Nifty

- Bank Nifty IV has decreased from 19.90% to 19.70% decreased by 1.01%




Nifty PCR

Nifty Option Open Interest


 Option build-up shows that Nifty has highest OI at 23500 followed by 23700 CE strike where Short Build-up is seen whereas on the PE side 23500 followed by 23300 strike holds highest OI where Long Build-up is seen which indicates the market participant expect market to trade below 23300 level till the time it is holding below 23700 level.






Nifty VIX

- VIX started the week with a high volatility of 14.11 gradually moving towards a low of 13.05 and closing at 13.05.
- The decrease in VIX indicates decrease in volatility.
- VIX trading near 13.05 can lead a move towards 15, whereas VIX trading above 15 can lead a move towards 18-21.
- We expect the VIX to trade between 11-16 level.



Nifty Future Open Interest


- The Nifty Futures started the week with an open interest (OI) of 13,718,325 contracts, with long positions being squared off.
- During the week, a total of 4,56,34,050 short contracts being added where else a total of 3,00,400 long contract where added.
- The Index started the series with 13,718,325 OI and currently the OI stands at 15,762,350 with price decrease by 0.93% which indicates Short Buildup.






FII's Index Future

- In previous week FII's Total Number of contracts in INDEX FUTURE conclude at 406936 compared to 348121 contract, increase by 58815.
- The total open interest position of FII's in Index future is at 406936 which on weekly basis has increased by 16.89%.
- During this period, the highest LS Ratio was 0.25 and the lowest was 0.19, indicating majority of the position made on the short side.




