# **KEY HEADLINE**

The Indian rupee rose on Friday after JPMorgan said it will include the country's bonds in its emerging market index, however, came off its opening highs on dollar demand from importers.

JPMorgan will include India in its widely tracked emerging market debt index, setting the stage for billions of dollars of inflows into the country. India's inclusion on JPMorgan's index will start on June 28, 2024, and extend over 10 months with 1% increments on its index weighting.

At the NSE Future Sep 29 contract, the rupee strong by 9 paise to closed at 82.97 against the previous close of 83.06 and made low of 82.84 and high of 82.99 during the day. Indian government bond yields fell on Friday, with the benchmark 10-year and the 14-year bond yields slipping to their lowest level in two months.

India's foreign exchange reserves dipped by \$867 million to \$593.037 billion for the week ending September 15, the latest data by the Reserve Bank of India (RBI) showed on Friday.

The U.S. dollar advanced against a basket of currencies on Friday as the latest batch of data on business activity from around the globe highlighted the superior position of the United States relative to other major economies.

S&P Global said its flash U.S. Composite PMI index, which tracks the manufacturing and service sectors, dipped to a reading of 50.1 in September from a final reading for August of 50.2. September's result was barely above the 50 level that separates expansion and contraction.
